Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2022 - 2023 educational progress for Genesee Early College. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2022-2023 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has a student subgroup performing at the same level as the lowest 5% of all schools in the state. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

Genesee Early College has not been given one of these labels by the State.

Genesee Early College continues to strive to meet the needs of all students. Genesee Early College continues to pursue professional development for its staff based on the data that is provided from state and local assessments. Assessment data is reported for the two most recent years, as required by state and federal law. Genesee Early College reviewed our Michigan Integrated Continuous Improvement Process (MICIP) goals in order to address concerns about retention and instituted a process each semester for evaluating struggling students' progress through performance improvement plans, to the program. This has enabled us to address concerns early in a student's career. We will be reassessing our strategies towards our MICIP goals. A preliminary look at this data indicates that we are moving in the right direction. Genesee Early College students have outperformed Genesee County schools in every area on the SAT in 2016-2017, 2017-2018, 2018-19 (particularly in the area of ELA) and 2021-2022 (all subjects). In 2022-2023 GEC led the county in Reading and Writing and 5th in the county for Mathematics on the SAT.

State law requires that we also report additional information.

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

Students apply to Genesee Early College beginning in February for the upcoming school year. GEC considers acceptance for grades 9, 10, and 11. After an extensive admission process, students who are accepted for admission transfer from their home districts to GEC's fiscal agent, Carman Ainsworth Community Schools, and are enrolled at GEC.

2. THE STATUS OF THE 3-5 YEAR MICIP SCHOOL IMPROVEMENT PLAN

GEC consistently assesses our MICIP goals and strives for continuous improvement. Our early college revolves around experience in degree fields of study and Career Technical Education. Decisions regarding curriculum, focus, and instructional methods are data-based. Our current MICIP Goals are as follows:

- Math Goal 75% of students will demonstrate growth in math on the STAR test assessment by Spring 2025
- English Goal 60% of students will demonstrate growth in reading on the STAR test assessment
- Whole Child goal The number of student referrals across all buildings will decrease by 25% by 2028 (district)
 - Building- Creating a positive behavior intervention support system in accordance with PPSC

3. A BRIEF DESCRIPTION OF EACH SPECIALIZED SCHOOL

GEC is a partnership between two of Genesee County's most renowned educational institutions, Genesee Intermediate School District (GISD) and the University of Michigan-Flint (UM-Flint). GEC is operated by the GISD, and located on the UM-Flint Campus. GEC serves Genesee County students who are interested in exploring careers serviced by a bachelor's degree and STEM (science, technology, engineering, and math) careers. Some of the advantages that GEC offers are: a rigorous high school curriculum, an opportunity to earn up to 60 college credits; a 60-hour work-based learning experience, and other Career Technical Education certificate courses. GEC adheres to the early college high school design principles:

- College-Focused Academic Program: Schools implement comprehensive, standards-based curricula that provide a bridge to postsecondary studies and incorporate both high school and college coursework.
- Comprehensive Student Support: Supports are offered to all students to meet their academic, social, and emotional needs in high school and the transition to college.
- Dynamic High School and College Partnerships: High schools and colleges take joint responsibility for students' educational success and establish structures that permit high school students to take college courses.
- Culture of Continuous Improvement: High schools and colleges engage in evidence-based discussions to continuously improve students' experiences and outcomes.
